#### Action:

Payments were made in 2 tranches as, once it was considered in Mid April that visits to partners would be made in early June, money was reserved in order to allow for any adjustments based on what was observed. The two organisations are very different but it was considered that the issues they faced 'balanced out' & there was no reason to differentiate with the 2nd payment.

The initial payment to Poland was later than that to Romania as WSEH was creating a separate account for their new voluntary organisation 'SUPPORT' - whose work is entirely with displaced Ukrainian families.

#### WSEH:

The families we support have basic accommodation provided by the City Council. The money we received has been extremely valuable because it allows us to discuss with the families what extra support can be provided. They have many needs & the finance should be to provide properly supported creative & sporting activities through the summer. We hope the activities will help the families improve their quality of life here as they continue to struggle to manage the trauma of uncertainty and separation.

#### Bethany:

We are very grateful for your decision to organize charitable events to support our mission to help the Ukrainian refugees who are settling in our city, Iași. The amount we received from the community in Bishop's Castle is already used to support the day centre for Ukrainian refugees we have been coordinating for several months. So far we managed to purchase for the activities we are organizing for the Ukrainian children and families educational materials and board games, a magnetic board, bean bags and other small items for the centre's activities. So far we have 83 unique beneficiaries who have participated in activities, out of which 49 are children and 34 are adults. The activities carried out are: June 1st - childhood celebration, 2 art therapy sessions for adults, English classes for children, 2 painting sessions for children, 1 group activities session for young people and children. We try our best to provide these people with help and opportunities so that their departure from home can be well endured. The community center we developed will offer them counselling, activities for children, material help, educational services and integration on the labour market.

# Purposes & Process

This agreement outlines the processes involved in providing finance directly to those engaged in providing care and assistance to refugees created by warfare in Ukraine.

The donors (named as 'sponsors' in the document) are based in the United Kingdom of Great Britain & Northern Ireland & by reason of distance, are unable to engage directly & physically in assisting those made vulnerable by the warfare.

# **Obiective & Mecanism**

**2.3** The payment shall be made to the bank account of the **Beneficiary**.

#### Reporting processes

The sponsoring agency does not require formal reporting of expenditure by the beneficiary.

Neither is any form of financial auditing to be required by the sponsor.

The monies are donated without reservation, saving that they are to be used for the benefit of those affected by the Ukraine conflict. The beneficiary has full control of the use the finance provided (without reference back).

The 'sponsor' agency, as representative of those communities, groups and individuals, requests that the beneficiary provides evidence demonstrating, in practical manner, that the finance has supported the actions they have taken to alleviate suffering and distress amongst Ukrainian refugees.

Photographs with brief, minimal notes, such as are used on Facebook & other social media sites, will usually be sufficient.

Photographs may be provided through notification to the donors, of the sites on which such information is available.

The collecting, assembling & provision of such evidence should not interrupt, disturb or distract from the efficient management of the work of the beneficiary.
